US HOUSE OF REPRESENTATIVES - DISTRICT 4



Valerie P. Foushee

A mother, a public servant, and a lifelong North Carolinian, Congresswoman Valerie Foushee is running for re-election to stand up to the chaos in Washington that's making life less affordable for hardworking North Carolinians and chipping away at our rights and liberties.

Top issues: Congresswoman Foushee is committed to fighting back against **attacks on our democracy**, defunding and **protecting our community from ICE**, making **healthcare more affordable** by passing Medicare for All, and working to **lower costs**.



Nida Allam

Nida Allam is a Durham County Commissioner and organizer who has expanded housing, raised wages, strengthened public schools, and expanded healthcare access. Daughter of immigrants, she's grassroots-backed, rejects corporate PAC money, and will fight for all of our communities.

Top issues: Address the affordability crisis by **lowering costs** for working families. Defend democracy with voting rights, fair maps, and **corporate PAC-free** politics. **Protect immigrant families** with paths to citizenship. Guarantee healthcare as a human right with **Medicare for All**.

US HOUSE OF REPRESENTATIVES - DISTRICT 13



Paul Barringer

Paul Barringer is an attorney, health care operations leader, and landowner who's worked for decades to fix broken systems. He's running for Congress to stand up for District 13, defend the Constitution, and put communities, not Washington, back in charge.

Top issues: **Cost of living** because North Carolina families are being squeezed, **healthcare** because care should be affordable and local, and **Constitutional balance** because Congress must reclaim its role.



Frank Pierce

Frank Pierce is the 1st Vice Chair of the Democratic Men of North Carolina. Frank is a small business owner of a landscape company. Frank is also a board member of Aids Alliance. He started the Feed the Firefighters of Raleigh program so they are fed every Thanksgiving and Christmas.

Top issues: **Affordability**, lowering cost of living and insurance. **Infrastructure**, increasing access to broadband as well as clean water in District 13. **Healthcare**, adding more access and **affordability** for all.

RALEIGH CITY COUNCIL AT-LARGE (SELECT 2)

Stormie is a Raleigh native. She's a licensed attorney and realtor. She's also certified as an Ombudsman, mediator, and rehabilitation counselor. As a lifelong Democrat, she'll continue finding solutions to the most pressing issues for the residents of the City of Raleigh.

Top issues: **Homelessness** and **affordable housing**, efficient/reliable **public transportation**, and improving/expanding **infrastructure**.

Top issues: **Responsible growth** focused on **affordability**, support for **small businesses**, competitive **staff pay**, and **community engagement**.



Cameron Zamot

Cameron Zamot is an entrepreneur, engineer, husband, and veteran. As owner of The Bike Library, he's committed to building community and getting people on bikes. As a former City employee, he's familiar with the municipal system and committed to making the city grow well.

Top issues: **Transportation** because if our city moves well, it will grow well. **Housing** because more housing options will bring down prices.

RALEIGH CITY COUNCIL DISTRICT C



Corey Branch

Corey has served District C for 10 years. The district has had more Affordable Housing projects than three other districts, and housing options across incomes have increased alongside transit stops/routes and youth non-profit funding.

Top Issues: Housing **affordability**, transit, & **youth programs**.

Jared Ollison is an Air Force veteran who served in the Middle East. He then served his community as a law enforcement officer for thirty years. He now seeks to represent District C.

NC COURT OF APPEALS JUDGE SEAT 3



James Weldon Whalen

James Whalen is fighting to protect our rights. As an attorney, he fought gerrymandering, halted legislative overreach, and stopped a dangerous attempt to discard thousands of votes and undo Justice Allison Riggs's victory. He'll continue fighting for us on the Court of Appeals.

Top issues: Current court majorities have allowed extreme **partisan gerrymandering**, blocked **public school funding**, & attempted to discard thousands of lawful ballots. Instead, James will **uphold our constitution**.



Christine Marie Walczyk

Judge Christine Walczyk has worked in law for 30 years. She is one of the longest-serving trial judges in our state and has a proven record of safeguarding due process and individual rights. As the only woman running for the Court in 2026, she hopes to give Democratic women a seat at the table.

Top issues: Protect **individual liberties** guaranteed by the Constitution, promote **equal access to justice**, build a **strong judiciary that works for the people**, and bring experience, integrity, and balance to the Court.

Sherita Walton

Sherita Walton is a seasoned attorney with over 20 years of legal experience. She has served as a prosecutor, a defender, and now as a legal advisor to the Raleigh Police Department, bringing a well-rounded understanding of the justice system to every role she's taken on.

Top issues: Strengthen the DA's office by protecting **public safety** and prioritizing violent crime, administering justice with **dignity and fairness**, fostering **transparency**, and expanding **diversion/prevention** programs.



Melanie Shekita

Melanie Shekita is a 27-year career prosecutor and head of the Special Victims Unit. She is committed to public safety by building an office rooted in trust, fairness, and accountability; one that reflects our growing and diverse community and holds the most violent offenders accountable.

Top issues: **Early intervention** with community partners to stem the rise in juvenile violence, promoting **accountability** both inside and outside the office, and keeping our communities **safe** with timely, efficient action.



Wiley Nickel

Wiley Nickel is a husband, father, and Wake County attorney who has spent his career fighting for justice. Working for President Obama, he learned that real leaders fight for change. As a State Senator and NC Congressman, he fought to defend voting rights and protect abortion access.

Top issues: Supporting **public safety**, taking on corrupt politicians, **standing up to Trump's attacks** on our communities, and keeping Wake County safe by pushing for **more resources for the DA's Office**.
